B. Status Report on Injunctions (AAG Ted Klecker) –

**Lorain County**: 2/28/07 - Injunctions filed on 3 shops. One went out of business, one registered (Rapid Auto Body) and one chose not to register Jeff's Auto Body (Jeff Gaines, owner). We filed a motion for contempt 9/07. Moved forward and a hearing was held Monday, December 3, 2007 and Mr. Gaines was found in contempt and ordered to pay \$150 and sentenced to 20 days in jail. The sentence was stayed and Mr. Gaines was given the opportunity to purge. He has until February 28, 2008 (90 days) to comply (either register or go out of business). A court date was set for March 14, 2008 at 1:30p. If Mr. Gaines is found not in compliance, the court will go forward with the original sentence of 20 days in jail and the \$150 fine.

**Hamilton County:** Monday, December 10, 2007, filed against 12 shops. Had service on 9 and 3 shops either didn't sign for the mail or it was returned not served. Filed requesting to have Personal Service by the Sheriff on the 3 remaining shops. None of the shops appeared on the set court date. Set another date for February 13, 2008. To perfect the service on the remaining 3 shops. If we do not receive an answer from any of the 9 shops, we're filing for a motion default judgment, we're pretty sure we'll be able to get the injunctions and go from there.

**Butler County:** The last 2 still have some service issues and we have not yet set a court date. We will be filing to perfect service by personal service.
