Registration & Requirements

- Obtain Registration form by calling 614.995.0714 or on our website at <u>http://mvrboard.ohio.gov</u> or you can register online via the portal at <u>https://elicense.ohio.gov/OH_Com</u> minitiesLogin
- 2. Remit \$228.50 annual registration fee (\$3.50 administration processing fee accessed by the new e-Licensing system.)
- Submit your federal and state taxpayer identification numbers, valid vendor's license number, workers compensation, unemployment identification numbers, and EPA permits.
- 4. Certificate of Insurance showing general liability and garage keeper coverage.
- Include two (2) photographs;
 (1) Showing your building and its sign, (1) Displaying vehicle entrances and exits into your shop. Mobile units should photograph a side and rear view of the vehicle.

Registration exempted groups include: motor vehicle, auction and salvage dealers; fleet operators (these entities are already licensed under other specific state laws and governance); hobbyists repairing four or less motor vehicles in a calendar year.


