B. Status Report on Injunctions (AAG Ted Klecker)

BUTLER COUNTY: There are 3 shops that are still not registered and are still doing business. On July 28th a 30 day letter was sent stating that we were going to contempt charges if they did not register: Anthony Bartel dba Paint and Dent Werks; Lane Couch dba Mirror Magic Auto Body; and Jim Fisher dba Fisher Collision Center. Three letters sent out, none responded.

Filed against Oops and they are now registered.

FRANKLIN COUNTY: Mitch Harris settled and is now registered, Chris Wood did not show, rescheduled to the 20th – certified mail service went out and it failed, personal service is now going to be used.

HAMILTON COUNTY: Hearing scheduled for the 19th and some shops are signing for their mail and some aren't. Those that aren't, will be served with personal services. The shops that we have service on Darryl Robinson dba Darryl's Paint and Body, William Burns, Jr. dba Allstar Auto Body, Mike Weigel dba Mike's Auto Body. The ones that aren't picking up their mail: Jessie Paige dba Jessie's Auto Body; Will Scruggs dba Will's Auto Repair & Body Shop; Donald Tye dba Tye's Collision & Conversion, Spade Auto Body dba Automotive Enterprises .
