- B. Status Report on Injunctions (AAG Ted Klecker) – AAG Klecker advised the Board that he had a draft of the 5 injunctions for Dir. Greene to sign for both Belmont (3) and Jefferson Counties (2). The 3 shops in Belmont County were mailed letters October 8, 2009, advising them they have 30 days to come into compliance. A total of 23 letters in five counties were mailed October 8, and AAG Klecker be following up in the coming weeks on the status of those businesses.
- C. Status Report on Legislation (ASA Adam Lemke) - Not much has happened since the last meeting. ASA is sitting tight on the legislation as far as shop licensing including mechanical, which is kind of where we were last time, with the budget still up in the air. ASA's stance is protecting this board as we have it, and that is what we have instructed our lawyers to do. At this point we're just trying to lay low and not ruffle too many feathers and not call attention to what we already have going on. When the budget issues are settled, we will reassess the licensing legislation and proceed with our plans.
