Mitch Harris dba Complete Collision Center: Court found an agreement entry that Mr. Harris was in contempt by not being registered. Mr. Harris had until December 1, 2008 to submit a complete application. The application was incomplete and he was notified of such. Mr. Harris has a payment plan that goes through February 2, 2009, he had made the first payment. If he has not completed everything by February 2nd, it will end up going back to court.

Darryl Robinson: The Magistrate found him in contempt for not registering. Mr. Robinson has until February 5, 2009 to register with the board.

Jessie Paige, Mike Weigel, Will Scruggs, William Burns and Spade Auto Body also have until February, 2009 to come into compliance.

Electro Mecanico Auto Repair has until February 23, 2009 to come into compliance, if not AAG Ted Klecker will be going back to court on this shop and the previously mentioned shops if they are not in compliance by their appointed dates.
